Flooded Properties

There have been no reports of flooding since the last meeting on 6th April 2022.

Flood Investigation Reports to finish

Location	Description	Latest investigation comments
Windermere Road, Kendal	Groundwater flooding	As discussed in recent meetings. Need to finalise report now.
Loftus Hill, Sedbergh	Various culvert and combined sewer issues	Outstanding flood report to finish after long flood investigation first reported in 2018. A previously unknown surface water drainage pipe in the highway was discovered to have been damaged by UU. Repairs complete but report to finish.
The Square, Burton in Kendal	Culvert flooding	Update to Burton in Kendal flood report needed after long investigation into cellar flooding. Repairs complete but report to update.
Lake Road, Windermere	Property Flooding	Outstanding flood report to finish after long flood investigation stalled due to not being able to progress with CCTV surveys. First reported in 2017.
Lion Cottage, Grasmere	Property Flooding	Have carried out investigation with Highways and UU. Highway drainage improvement in pipeline for 2022/23.

North Road, Holme	New flood relief culvert	To be retendered soon.
Aldingham	Replacement outfall	Expected to start construction by 11 th April.
Low Garth, Kendal	Upgraded piped system with overflow to basin	Currently under construction after detailed redesign. Led by Capital Projects team.
Windermere Road, Grange over Sands	Surface Water pumping station D&B and NFM at The Slack	NFM works have been completed. Funding for pumping station secured.
Beetham	Surface water interception and divert to River Bela.	Redesign is needed due to a planning approval being awarded for the same land. Consultant to be appointed.
