## **Update** – what we've been up to

We have completed a round of ground investigation works to understand the area's soil types, rock formations, ground water levels and other subsurface conditions. We have been contacting landowners to provide access and tried to be good neighbours while we do this investigation work.










- Completed options phase of project in October 2023
  - Original contraflow was 10km long, but we have reduced this to 5km.
  - ✓ Use of specialist gantry cranes much easier to install and less obtrusive than standard cranes – safer for road users/workforce and reduces requirement for full closures.
  - ✓ M6 J38 closures one side of J38 kept open to maintain access.
  - Diversion via J39 return or J37 return.

The benefits that we and our suppliers deliver for people, the environment, and the economy.


- The Social Value Fund was established in October 2022 and is designed to enable our project teams to be a 'good neighbour' by delivering support to local communities impacted by our work.

- Shared stakeholder manager and shared engagement












### A66 Northern Trans-Pennine Upgrade | Project Objectives

The strategic objective of the project is to investigate the potential to create a new improved strategic corridor linking the A1(M) with the M6 by upgrading the A66 corridor and making other improvements along its length.

- Safety A consistent standard of dual carriageway with the same speed limit throughout, may reduce the number of accidents. Use of the 'old' A66 as part of the local road network will provide better, safer routes for cyclists and pedestrians.
- Connectivity Improving connectivity for people living and working nearby and creating better facilities
  for cyclists and pedestrians. Reducing congestion and improving the reliability of people's journeys
  between the M6 at Penrith and the A1(M) Scotch Corner and nationwide. It also improves connectivity
  between the key employment areas of Cumbria, Tees Valley and Tyne and Wear.
- Environmental Minimising noise levels for people living and working near the route and reducing the
  congestion currently occurring in the single carriageway sections. The project is also being designed to
  minimise any potential negative impacts on the natural environment and landscapes of the North
  Pennines and Lake District.
- **Economic** Improving strategic regional and national connectivity, particularly for hauliers. Heavy goods vehicles account for a quarter of all traffic on the road and any delays to journeys can have an extremely negative effect on business and commerce, including lost working time and missed shipment slots.
- Tourism Improving access to key tourist destinations such as the North Pennines and Lake District.
- **Community** Re-connecting communities and providing better links between settlements along the route as well as improving access to services such as healthcare, employment areas and education.
- Capacity Reducing delays and queues during busy periods and improving the performance of key
  junctions such as the A66/A6 and the M6 junction 40.
- Increasing reliability An improved A66, with consistent speed limits, will lead to less accidents which, in turn, makes the road more reliable. Also, having a dual carriageway provides the option to close lanes where required due to accidents or break downs and still keep traffic moving.








## **Project update**

- § SoS DCO decision was granted on 7 March 2024.
- § Archaeology investigations ongoing.
- § Work has started to divert a gas pipe from alongside of the A66.
- S The legal challenge period has now concluded and awaiting the outcome of that.
- § Design work is continuing and engagement with local landowners and impacted stakeholders.
- Construction start late 2024.











- We've got a target of £150m worth of social value which needs to be generated as part of the A66 scheme. To date we've generated over £11m worth of social value.
- On top of this we've also successfully received money for four separate social value bids via the National Highways social value bid
  - Carlisle youth zone
  - **Teachers Encounter**
  - Catterick Garson Veterans
  - **Newton Rigg**




## What's next


- § Accommodation strategy is being developed.
