However, when the interest is no longer considered to be a "sensitive interest" you must notify the Monitoring Officer within 28 days of that change.

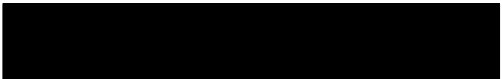

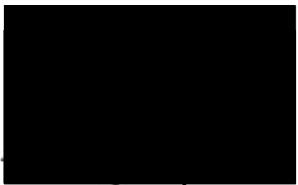
