A "sensitive interest" is an interest which could result in, or is likely to result in a serious risk that you, or a person connected with you, may be subjected to violence of intimidation. Where you consider that this may apply to you, you should consult the Monitoring Officer. Subject to their agreement, you may not need to include that interest on this form. However, when the interest is no longer considered to be a "sensitive interest" you must notify the Monitoring Officer within 28 days of that change.
